

## PRIVACY POLICY

### USA- EU Transatlantic Business Summit

#### 1. Who We Are

The USA- EU Transatlantic Business Summit (“Summit,” “we,” “us,” or “our”) is organized by Polish & American Women Entrepreneurs Association (Polish & American WE) nonprofit organization 501(c)(3) dedicated to advancing entrepreneurs across the U.S. and EU markets by fostering high-level networking and transatlantic collaboration.

#### 2. Scope of This Policy

This Privacy Policy explains how we collect, use, and protect personal data provided through our website and registration process for the USA-EU Transatlantic Business Summit.

#### 3. Personal Data We Collect

We collect only professional identification data voluntarily provided by you:

- First name
- Last name
- Company
- Job title
- Professional email address

We do not collect sensitive personal data.

#### 4. Purpose of Processing

Your personal data is processed exclusively for the following purposes:

- Managing registration and participation in the Summit
- Communicating essential event-related information
- Verifying eligibility for this invitation-only event
- Organizing and administering Summit activities

Your data will **not** be sold or used for unrelated marketing purposes.

#### 5. Legal Basis for Processing

Where applicable under EU data protection law (GDPR), we process your data based on:

- Your consent provided at registration; and
- The necessity to perform activities related to your participation in the Summit.

#### 6. Data Sharing

Your personal data may be shared only with:

- Trusted service providers supporting event organization and administration

All such parties are required to process personal data securely and in compliance with applicable privacy laws.

## 7. International Data Transfers

As a U.S.-based 501(c)(3) nonprofit operating transatlantically, personal data may be processed in the **United States or the European Union**. Appropriate safeguards are applied to protect personal data in accordance with applicable regulations.

## 8. Data Retention

Personal data is retained only for the period necessary to organize the Summit and meet legal or administrative obligations. After that period, data is securely deleted.

## 9. Your Rights

Depending on your jurisdiction, you may have the right to:

- Access your personal data
- Request correction or deletion
- Withdraw consent at any time
